- A. Elementary School: Sugar Mama Bakery & Catering has started dine-in meals and vendor shows are taking place on Saturdays. The sign for Sugar Mama Bakery & Catering has been installed on the school building. Dena's grand opening will be taking place during Hendrum Family Fun Night. The bus garage was cleaned out and is ready to be listed for sale. On the final day for submission the city was informed of an energy improvement grant that may be applicable for upgrading the heating system at the school building. Rich Whitcomb, CEO of Red River Valley Power Co-op, offered his expertise in writing to complete the grant application in such a shortened timeline. The application is requesting \$550,000 for a geothermal system to replace the 1950's era boiler which is estimated to significantly increase the energy efficiency of the heating system and to offer cooling in the summer.
- **B.** Yard of the Month: Karen Jacobson at 326 Rice St. N. was awarded Yard of the Month for August.

- **D.** Hendrum Family Fun Night: Hendrum Family Fun Night will be taking place on Wednesday, August 23rd and will host a classic car & antique tractor show, craft & vendor shows, fireman's games, corn feed meal, 5k fun run, and much more.

A. Mural: Northwestern Bank is interested in having a mural painted on the west wall of their building facing Highway 75. A mural artist has provided a quote for the space and Ann Tommerdahl has offered to write the grant proposal but will need a government sponsor to qualify.
