# **Regular Council Meeting Minutes**

November 13, 2023

### **CALL TO ORDER**

2. Liability Coverage Waiver Form: Every year members who obtain liability coverage from LMCIT must decide to waive or not waive the statutory tort limits to the extent of the coverage purchased. The council chose not to waive the monetary limits for the City of Hendrum.

*MOTION: M. Smart* moved; seconded by *P. Baukol* to choose not to waive the monetary limits on municipal tort liability established by Minnesota Statutes 466.04.

3. VOTER allocation funds: Norman County received state funding for county and municipal election administration. The funds received were allocated based on a percentage of voters in each city/township. Hendrum is entitled to receive \$45.73. To receive these funds, an agreement must be made on the distribution plan, along with specific use of the funds and reporting requirements. The city will need to enter into an agreement with the county to receive the funds.

*MOTION: P. Baukol* moved; seconded by *M. Smart* to enter into the agreement with Norman County to receive its portion of the Voting Operations, Technology, & Election Resources (VOTER) Allocation Funds and to authorize Clerk-Treasurer Plemmons to execute the agreement.

The schedule will be posted on the city website, Facebook and posters at the post office, bank, and city hall. The December schedule will be created at the December 11<sup>th</sup> city council meeting.

- **E.** Wellhead Protection Grant: The generator has been ordered.
- **F. Ztrack Lawn Mower:** Two quotes were reviewed for lawn mower replacement. The lowest bid came from Valley Plains Equipment and was accepted by the council.

*MOTION: P. Baukol* moved; seconded by *M. Smart* to purchase the John Deere Z970R ZTrak from Valley Plains Equipment for \$16,600.00 to be financed through United Lease and Finance, Inc. on a five-year program, structured with the first semi-annual payment and documentation fee due at

signing and to authorize Mayor Johannsen and Clerk-Treasurer Plemmons to sign any documentation necessary to effectuate the transaction.
