UNFINISHED BUSINESS

- **A. City Ordinance Violations:** Councilmember Lopez asked about winter parking regulations and what would be considered a parking violation.
- **B.** City Street Paving Project: There is an opportunity for Hendrum's city street paving project to be included in the Minnesota delegation's request for congressionally directed spending. The engineer is preparing the city street paving project proposal and will forward the information to Congresswoman Michelle Fishbach's office.

Proposed Water Supply Project: The proposed water supply district, West Central Regional Water District, has created a website (https://wcrwd-ae2s.hub.arcgis.com/) with ongoing information and updates as they continue to pursue funding. A representative has been invited to the April meeting to provide an update to the council.

C. Elementary School: The owner of the baking and catering business is planning to open by Easter weekend. The developer is continuing to pursue funding sources. Red River Valley Co-op has requested to amend the rental agreement to only be charged for half of the heating expenses as they are not occupying the entire building with the effective date of January 1, 2023.

MOTION: M. Smart moved; seconded by *B. Schlapkohl* to amend the original rental agreement with Red River Valley Co-op to bill half of the heating expenses effective January 1, 2023.

- **D. Wellhead Protection Grant:** Councilmember Smart provided quotes for the electrical work to connect the generator. The council concluded that the electrician should be consulted about the two generator options before a final purchase decision is made.
- **E. Wetland Conservation Act:** A Resolution to delegate administrative responsibility to implement the Minnesota Wetland Conservation Act within the legal boundaries of the City of Hendrum to the Norman County Soil and Water Conservation District was introduced for approval.

MOTION: M. Smart moved; seconded by *P. Baukol* to adopt Resolution No. 2023-05: A Resolution Regarding the Administration of the Minnesota Wetland Conservation Act. By the following roll call vote the resolution was duly adopted and is on file at the City Clerk's office.
