- A. 304 Main Street East (REACH): Peggy Chisholm presented an update on the REACH ReUsables Thrift Store in Hendrum. The sales revenues have been really close to reaching the targeted goals. There are currently 8 volunteers working 30 hours per month helping with the sorting in the back room. REACH was able to supply the Norman County West Elementary school (NCWE) with 42 backpacks through their Backpack Program. They also have been able to provide backpacks of food on the weekends to 55 children from NCWE per week. Proceeds from the thrift store help to fund these programs. REACH also promotes \$5 bag sales on clothing and shoes the first Wednesday, Thursday and Friday of each month. Ms. Chisholm also presented an overview of the Winter Gear Pickup happening soon and the Spirit of Giving programs that will be taking place for Thanksgiving and Christmas.
- **B.** Yard of the Month: The committee will be meeting to award the Yard of the Month recipients designated at the previous meeting.
- **C. CARES Act:** Norman County will be awarding CARES Act funding to help businesses located within Norman County who have been affected by COVID-19. The Norman County EDA will be tasked with dispersing the funds. The funding information will be posted on the City Facebook page when the details become available.
