CITIZEN'S FORUM

Mr. Tyler Kolness was in attendance to discuss plans to update the Discover Norman County publication that gets printed every few years. Discover Norman County is a full color magazine that focuses on all the positive aspects of our communities throughout Norman County, MN. The publication is directed toward newcomers to the area, visitors, potential new business and industry, as well as current residents. For the first time, the upcoming print of the magazine will be available at all the Minnesota Tourism rest areas. Mr. Kolness informed the Authority that aerial photography has also been gathered this year and will be available for use by the cities to promote their communities.

PUBLIC HEARING

The public hearing regarding an *Application for Conditional Use Permit* (CUP) filed by MinneStPopolis Admin, LLC on behalf of UBHomeNow, LLC pursuant to Subd. 5, Ordinance No. 74: Planning & Zoning (Land Use) for the operation of a commercial rental display site at 402 Gordon Street East, City of Hendrum, State of Minnesota, was opened at 6:48 pm to hear any questions or commentary regarding the application. Mr. and Mrs. Schnabel presented their plan to use the residential lot that is adjacent to their commercial business to display equipment available to be rented by the public. Having no written commentary

submitted to the city office and no members of the public in attendance, the hearing was closed at 6:56 pm.

CUP Application:** Discussion took place between Mr. and Mrs. Schnabel and the board members regarding maintenance of the display area and paring down the property area covered by the CUP to the lot that the display area will be located rather than the entire property as originally requested.

community. President Johannsen will go through copies of the aerial photographs at a future date and make the selections for the advertisement.
